As we all know, attention to preschool education has increased in recent years. The number of preschool education organizations, non-government, as state, family, such partnership, is also increasing year by year. In these order to provide educational organizations with personnel The scope of admission in higher education institutions is expanding and the quality of education is also increasing. We all know the importance and necessity of preschool educational organizations today to develop a child in all aspects and raise him as a well-rounded person. The correct organization of educational work is of great importance. The importance of the pedagogic council in the management of the organization and the regulation and improvement of the effectiveness of the educational process is extremely great. can be considered by the heads of the structural departments of the departments, suggestions can be made and agreed upon by the head of the district and district pre-school education department.

Pedagogical councils are planned to be held 4 times during the academic year (in August, November, February, May). At each council, topics are planned based on the main tasks of the educational organization. actual issues aimed at increasing the capacity of personnel and the quality of education are included. The general documents of the Pedagogical Council minutes and decisions are kept in the folder named 01-14.

The Pedagogical Council determines the pedagogical workload of the pedagogues, considers the issues of improving the educational process of the preschool education organization, and evaluates the results of the implementation of educational programs. The legal representatives of the child determine the procedure for cooperation. The pedagogue of improving examines the issues the qualifications of the employees, developing their creative initiative, introducing advanced pedagogical experiences, considers the issues of material and moral stimulation of the organization's employees. the listens to reports of the leaders and pedagogues.

The chairman, its members and secretary are elected to the pedagogical council. The book of minutes of the council and the analytical materials and information prepared for discussion are kept in the secretary. The minutes of the council are written by the secretary of the council.

Issues included in the plan of the Pedagogical Council will be studied by the responsible working group with one month's The information prepared on the notice. results of the study and the draft decision will be submitted to the members of the pedagogical council 10 days in advance. Additions and changes may be made based on suggestions and recommendations given by the members of the council. After each issue in the minutes of the Pedagogical Council, a decision is made within a specified period, the person responsible for the implementation of the decision is assigned to it, and the implementation of these decisions monitored at the beginning of the next Pedagogical Council according to the quality assurance of their implementation.

The results of the analysis and all the documents related to the studied issues will be created. The Pedagogical Council Minutes Book must be stitched, filed, signed and sealed by the head of the preschool education organization.

Chapter 9 is called the procedure for managing the preschool education organization and organizing its activities. Article 48 of this law is called "Management of Preschool Education Organization", and the State Preschool Education Organization is managed by:

- pedagogical council;
- supervisory board;
- head of the state preschool education organization.
- The procedure for managing a nonstate preschool education organization is determined in its founding documents.

Article 49 of the law is about the pedagogical council of the state preschool education organization, and it is explained as follows:

The Pedagogical Council of the State Preschool Education Organization is a collegial management body of the State Preschool Education Organization, which consists of pedagogic employees and exercises powers to discuss issues related to its pedagogical activity. Tasks performed by the Pedagogical Council of the State Preschool Education Organization:

- considers the issues of organizing and improving the educational process in the state preschool education organization;
- determines the work plan of the state preschool education organization and the pedagogical workload of the teaching staff;
- evaluates the results of the implementation of the educational program of the state preschool education organization;
- determines the procedure for interaction between the state preschool education organization and the child's legal representatives;
- discusses the issues of improving the qualifications of pedagogic staff of the state preschool education organization, developing their creative initiative, introducing scientific achievements and advanced pedagogical experience into the education and training process;
- considers issues of moral and material encouragement of employees of the state preschool education organization;
- listens to the reports of the head of the state preschool education organization and pedagogic staff.

The pedagogical council of the state preschool education organization may exercise other powers in accordance with the legislation.

The work of studying and popularizing previous work experience is also carried out by the pedagogical council, the previous work experience of the pedagogue is studied for one year, publicized in one year (second year), and the documents used and popularized in the third year are summarized and recommended for popularization at the district level. Previous work experience is discussed in the study-seminar or production meetings, popularization in the pedagogical council.

"We can say that there are more important priorities that we need to do in the preschool education system than we have done so far. Further improvement of the pre-school

education system, expansion of the network of pre-school education organizations and strengthening of the material and technical base, providing them with qualified pedagogic personnel, modern educational programs for the all-round intellectual, spiritual-aesthetic and physical development of children and Our main goal is to introduce technologies in the educational process, to radically increase their level of preparation for school. Because our tomorrow and our future depend on our little children who are growing up and being educated in pre-school education organizations today," says our honorable president Shavkat Miromonovich Mirziyoyev.
