Introduction

Results

On the other hand, the work is carried out on the basis of the ancient rich spiritual, cultural, historical and legal heritage of our people, a separate group, on the other hand, on universal human values, international legal experience. The Constitution of the Republic of Uzbekistan recognizes the interdependence of a citizen and the state, their duties and rights enshrined in Article 19 of the Constitution: "A citizen of the Republic of Uzbekistan and the state are bound by mutual rights and mutual responsibility. The rights and freedoms of citizens, enshrined in the Constitution and laws, are inviolable, and no one has the right to deprive or restrict them without a trial" [4, 7]. The protection of civil rights from the powers of state power is an important value of civil society. Human rights represent the scope and standard of justice, equality and freedom. Uzbekistan establishes the following important
international legal norms relating to intellectual
property rights, and above all, the duty of the
state to recognize and protect intellectual rights
and freedoms. In Uzbekistan, the system of civil
rights and freedoms complies with international
legal norms and recognizes the supremacy of
tinternational law in this area. It is recognizedd

that everyone and everyone has equal rights and freedoms. Rights and freedoms constitute the content of the activities of state bodies. The exercise of human rights and freedoms must not violate the rights of others.

Discussion

In the life of society, legal awareness is manifested in both positive and negative behaviour of the individual. In a democratic state, the formation of civic responsibility and law-abidingness among young people is carried out both through moral and legal consciousness. Legal values are legal systems, views, principles and practices that are valued by citizens in regulating relations between people, the state and society, and serve national values and their interests. "The structure of social responsibility, which performs value-normative, regulatory and creative functions, appears to us as an interdependence of three components: cognitive, motivational and activity" [6, 17]. If we consider from this point of view, cognitive quality means a system of knowledge acquired by a citizen about the content and essence of personal rights and obligations, rules and norms of personality behaviour in public life, ways of regulating them. In Uzbekistan, the honour, dignity, rights and freedoms are fully guaranteed by the Constitution.

The development of morality and culture of citizens in Uzbekistan is accrued on the

development of people based on the best practices of world ethical thinking and sociopractical actions. The formation of moral values in man and citizens begins with the family. The spiritual and moral environment, which finds in society, serves for the development of moral consciousness and moral culture. The basis of the spiritual values of society are morality, faith, intelligence and religious values. The inner world of man is his spiritual wealth, and the skillful use of such wealth is important for both a person and for society. Ethical values are a positive national language, family, historical heritage of society.

The basis of ethical rules is the basis of moral rules, humanity, kindness, humility, discipline, conscience, zeal, faith, duty. Any actions and exercises that occur in the development of society are regulated on the basis of ethical and legal norms. In the process of development of society, morality is expressed in the internal state of the spiritual beliefs of society, and the moral culture of a person directly represents the manifestation of this faith in practical activity.

Conclusion
