- control of law enforcement agencies and coordination of their law enforcement activities;

on the enforcement of laws aimed at compensating economic damages control;

- control over the implementation of laws in the places of detention of detainees, pretrial detention, court-ordered punishment and other compulsory measures;

- Control of compliance with laws in the Armed Forces;

- conducting a preliminary investigation of crimes;

- participation in improvement of legislation and promotion of laws and improvement of legal culture in society.

The prosecutor's office of the Republic of Uzbekistan shall be within the framework of a single centralized system headed by the Prosecutor General of the Republic of Uzbekistan in the order of subordinate prosecutors to higher prosecutors. They exercise control and their powers independently of state power and local authorities, officials, and public associations, strictly following the laws, international and interstate agreements (agreements) in force in the Republic of Uzbekistan, and the Prosecutor General of the Republic of Uzbekistan. works submissively. The Prosecutor General and his deputies are appointed and released from their positions in accordance with the decree of the President of the Republic of Uzbekistan, after passing the approval of the Senate of the Oliy Majlis. The Prosecutor of the Republic of Karakalpakstan, in agreement with the Prosecutor General of the Republic of Uzbekistan, is appointed by the supreme representative body of the Republic of Karakalpakstan. Prosecutors of regions, district and city prosecutors are appointed with the permission of the Prosecutor General of the Republic of Uzbekistan. The term of office of the Prosecutor General of the Republic of Uzbekistan, the Prosecutor of the Republic of Karakalpakstan, regional, district and city prosecutors is five years. The prosecutor's office has done a lot of work this year, and several important works have been completed that were satisfied by our society. Including the idea of the President of the Republic of Uzbekistan on July 12, 2018 "To obtain a high level of intellectual and social development of ancient cities, to develop their lifestyle and tourism network" and on July 5, 2019 A number of successful works, such as the ideas of clothing "social and financial development of p-level shahristan". Also, the prosecutor's office strives to further develop and strengthen the competition system. They are highly certified and gualified in law and are experts in law enforcement.
